
Properties can be let if they have an energy rating from A to E.

# **Energy rating and score**

# How this affects your energy bills

| 4. Condensing boiler                  | £2,200 - £3,000           | £97                   |
| 5. Solar water heating                | £4,000 - £6,000           | £34                   |
| 6. Solar photovoltaic panels          | £3,500 - £5,500           | £365                  |
